Description of Xtinguish Carpet

The term artificial grass is taken to mean a tufted polypropylene broadloom floor covering that is woven on a wide loom and are installed wall – to – wall indoors.

Artificial grass is supplied in full rolls of either 2.0m or 4.0m wide. Partial rolls are also available.
