# **Description of Carpet tiles**

The term carpet tile is taken to mean tiles of tufted carpet that are woven on to a tile or plank format to be used as a wall – to -wall floor covering.

Belgotex (NZ) Ltd supplies carpet tiles comprising of a synthetic fibre pile. This tufted pile is woven into a primary backing material, and a secondary backing material. Carpet tiles can be either laid loosely, with double sided tape, or adhesive. Carpet tiles are supplied in plank or tile format by the square metre.

When installed a Belgotex (NZ) Ltd carpet tile may contribute to G6 (airborne & impact sound) of the building. Compliance with this clause would need to be established as part of the proposed flooring system.
