Commercial Heterogeneous Sheet Vinyl as nominated on our range statement.

### **Description of Commercial Heterogeneous Sheet Vinyl**

The term sheet vinyl is taken to mean printed vinyl supplied in wide roll format to be installed wall – to – wall rated for use in Commercial and/or Industrial environments. The term heterogeneous is taken to mean that the product is manufactured using layers fused together under pressure and high temperature of differing materials, for example backing, print, and wear layer.

Belgotex (NZ) Ltd supplies heterogeneous sheet vinyl comprising of a polyvinyl chloride material, with a backing and a wear layer for durability. Heterogeneous sheet vinyl is supplied in full rolls of either 2.0m, 3.0m or 4.0m wide. Partial rolls are also available.

This range statement also covers Belgotex supplied Weld rod, clean corner, ramping, coving, and edging as part of the installation system as an accessory product.

When installed a Belgotex (NZ) Ltd heterogeneous sheet vinyl may contribute to G6 (airborne & impact sound). Compliance with the clause would need to be established as part of the proposed flooring system.
