### **Description of Laminate Flooring**

The term Laminate Flooring is taken to mean a direct pressure laminate containing a high-density fibreboard (HDF) core which is then coated with a timber veneer, and a protective coating.

Belgotex (NZ) Ltd supplied Laminate Flooring is a floating floor covering installed without adhesives or fixings and has a watertight click system.

When installed a Belgotex (NZ) Ltd laminates may contribute to G6 (airborne & impact sound) or H1 (energy efficiency) of the building.

Laminate flooring is supplied in plank format by the square metre.
