Description of Needle-punch Carpet

The term Needle-punch is taken to mean synthetic fibre broadloom carpets that are woven on a wide loom without a secondary backing material to be installed wall – to – wall.

When installed a Belgotex (NZ) Ltd needle-punch may contribute to G6 (airborne & impact sound) or H1 (energy efficiency) of the building.

Needlepunch carpets are supplied in full rolls of either 2.00m, 3.00m or 4.0m wide. Partial rolls, and tiles are also available.
