Description of Door & Wall Protection

Belgotex supplied Door and Wall Protection supplied by Belgotex are sheet vinyls for installation on vertical surfaces for moisture and impact protection. The products are heterogeneous, taken to mean that the product is manufactured using layers fused together under pressure and high temperature of differing materials, for example backing, print, and wear layer.

Belgotex (NZ) Ltd supplies wall and door protection comprising of a polyvinyl chloride material, with a backing and a wear layer for durability. Heterogeneous sheet vinyl is supplied in full rolls of either 2.0m wide, or panels/tiles. Partial rolls are also available.

When installed a Belgotex (NZ) Ltd luxury vinyl tile may contribute to G6 (airborne & impact sound) or H1 (energy efficiency) of the building.
