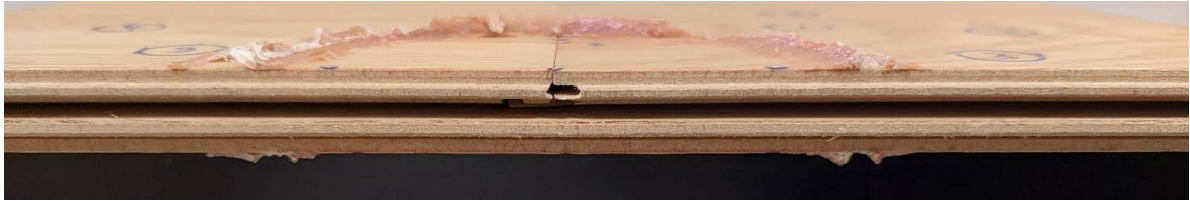


Figure 2 - Photo of sample 1 after disassembly

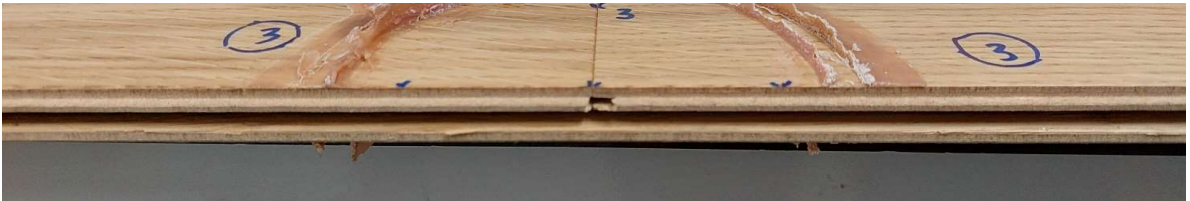


Figure 3 - Photo of sample 2 after disassembly

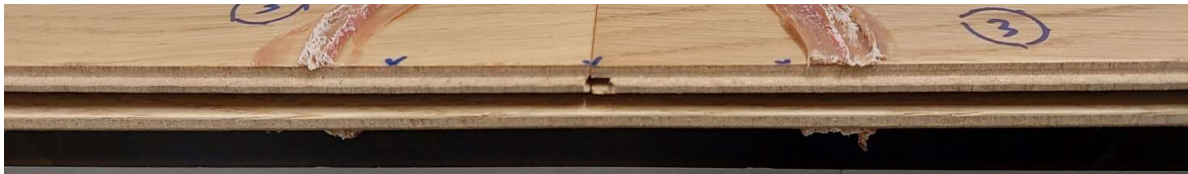


Figure 4 - Photo of sample 3 after disassembly
